Both the LWF and the ILC are honouring the commitment they made to meet with one another as agreed in the memorandum of understanding from March 2005.

Major items to be noted

- 1. Participants noted with appreciation that the present is the fourth consecutive meeting since the year 2011. The regularity of the meetings has provided a space where deeper discussions on theological matters and more open exchange on detected difficulties in the relationships on local and regional levels have become possible. On the basis of this assessment, and in the expectation of rich fruits to be enjoyed through further direct interaction between ILC and LWF, both sides agreed to continue holding annual meetings in the future.
- 2. Reviewing specific cases where conflicts have emerged, clarification was provided and follow up processes were agreed upon. In more general terms, the discussions

revealed the necessity to engage in deeper discussions regarding:

- a. The theology of mission as it prevails in both ILC and LWF contexts;
- b. The concept of unity of the church as understood both in ILC and LWF.
- c. The expectations between ILC and LWF for further developing their mutual engagement. It was proposed in this context to reflect on protocols between ILC and LWF, at this time on the global level, which ILC and LWF would want to agree upon.
- 3. The Reformation anniversary 2017 was discussed throughout the meeting. ILC and LWF are at different stages in their preparation processes and the specific programs designed for this important event. ILC expressed appreciation for the document *From Conflict to Communion*. The LWF welcomed the proposal of ILC to engage in a deeper study of the document.
- 4. In the context of the discussions about the document *From Conflict to Communion*, ILC indicated initial discussions regarding a new approach to study the *Joint Declaration on the Doctrine of the Justification* (JDDJ), signed between the Vatican and the LWF in 1999.

25-26 February 2016 were fixed as the dates for the next meeting, which would be hosted by the ILC.
